

### TERMS AND CONDITIONS OF INTER LIBRARY LOAN SCHEME:


1. We can loan only books in ILL. However, the reference books cannot be shared.
2. The demanding college should pay both sided postage expenditure.
3. In case of loss of books the concerned college has to replace the same edition copy or to pay the price of the books. If books torn or damaged while using, the demanded college should pay the books damage expenditure.
4. If any teacher demands the books personally, then the books will not be used without permission letter of the Principal.
5. If the sent books are missed, then the receiving college is responsible for the replacement of the books of the same condition.
6. Books can be kept for maximum one month only.
7. The issued books should not be handed over to any other person not concerned to your college.
8. At a time, maximum 10 books can be given under this scheme.


